REGISTRATION CONDITIONS

Cancellation Statement

Cancellations received in writing (events@ahuri.edu.au) to AHURI before Monday 11 September 2023 will be accepted and all fees refunded less an administrative fee of AUD \$100. Cancellations received after this date cannot be accepted and will not be refunded. A replacement delegate may attend the conference instead of the original delegate – must advise in writing of change sent to events@ahuri.edu.au.

Transfer of registration

Your registration can be transferred to another person and is free on the first occasion; subsequent changes will incur a cost of an administrative fee of \$100 GST inclusive (this includes transferring the already transferred registration to another person). The full name and details of the person that will replace you must be advised in writing (events@ahuri.edu.au) to AHURI prior to the Conference.

Non-attendance: No refunds will be made for non-attendance at the Conference.

SUPER SAVER & EARLY BIRD DISCOUNT CONDITIONS

To qualify for Super Saver discounted registration, booking must be made by 30 April 2023 and payment is received in full by 5 May 2023. Early Bird registration, registration must be made by 30 June 2023 and paid in full by Friday 7 July 2023. Registration fees received after this date will revert back to the standard conference applicable rate. Registration fees are based on date of payment receipt, not the date of receipt of registration form.

After Friday 1 September midnight AEST, only payments made by credit card will be accepted.
